**Northeast Region** – Deb submitted her report via email.

**SW region** -Nena reported that there are 2 good shows in conjunction with the Sweetwater County Museum and the Library happening now. There is a fundraising group for Quilting on the Green and they will be making barn quilt blocks.

**Northwest Region** – None presented at meeting.

**Southwest Region** – None presented at meeting

**Central Region** – Julie reported that the Popo Agie Quilters will have a class on March 18-20 and will be taught by Danette Moore. Contact Jenny Richardson for more info and to participate.

**Director-At-Large** – There are 3 Kid camp requests. Rock Springs has requested \$300, Torrington requested \$325, and \$300 was requested for Buffalo. These are the same folks who have been doing kids' camps in the past. There is \$2000 budgeted for this each year. There is a limit of \$35/student. Some may be getting donations to help cover their costs. \$347 for Goshen County Quilters was all we paid last year for Kids' Camps. Teresa moved and Nena Second that we accepted the 3 kid camp requests.

**Show and Regional Camp Requests:** NE Region has already requested funds for their show. And the Central region requested \$600 has for the Central Rendezvous. Stephanie moved and Tauna seconded that this request be approved; motion passed.

**Golden Thimble Awards:** Please consider submitting a nomination for the Golden Thimble awards and names for new regional directors for Central and SW Regions.
